This data privacy statement explains how Taquanta processes the personal information collected from you and also informs you of your rights in terms POPIA.

## **PERSONAL INFORMATION PROCESSED BY TAQUANTA**

Depending on the type of business conducted, or the relationship you have with Taquanta the following types of personal information may be processed:

- Name
- race (for employment or regulatory purposes only)
- gender
- marital status
- nationality
- age
- qualifications
- financial information
- employment history
- tax identification numbers
- contact details
- bank account details

## **WHY TAQUANTA MAY PROCESS YOUR PERSONAL INFORMATION**

Taquanta collects, stores and uses your personal information primarily for the following purposes:

- To communicate requested information to you
- To provide investment management services to you as requested
- To meet regulatory obligations such as is contained in (although not limited to) the Financial Intelligence Centre Act, 2001 ("FICA"), Financial Advisory & Intermediary Services Act, 2003 ("FAIS") and the Collective Investment Scheme Control Act, 2002 ("CISCA").
- To communicate additional products and services offering by Taquanta that may be of interest to you
- To provide occasional newsletters and market insights if requested

## **YOUR RIGHTS AS A DATA SUBJECT**

Taquanta recognises that all its data-subjects have the following rights regarding their personal information:

- The right to expect that Taquanta uses their personal information appropriately, transparently and securely.
- The right to establish whether Taquanta holds personal information related to them, including the right to request access to that personal information.
- The right to request, where necessary, that their personal information be corrected or deleted where Taquanta is no longer authorised to retain the personal information.
- The right to submit a complaint to the Information Regulator regarding an alleged infringement of any of the rights protected under POPI and to institute civil proceedings regarding the alleged non-compliance with the protection of their personal information
- The right to be notified in any situation where Taquanta has reasonable grounds to believe that the personal information of the client has been accessed or acquired by an unauthorised person.



## **SECURITY SAFEGUARDS**

The information Taquanta maintains concerning its data subjects is stored in secure databases that have built-in safeguards to ensure its privacy and confidentiality. Your personal information is strictly access controlled, with access granted to identified authorised persons only.

## **DATA SECURITY BREACHES**

In the event of a security compromise where your personal information has been accessed or acquired by an unauthorised person, Taquanta will notify you directly as soon possible as provided for in POPIA.
